16 I, Dennis Schuelke, having a relationship with Spencer Curtis Schuelke and having
17 firsthand knowledge of the facts stated herein, and being competent in mind and body to testify,
18 declare and affirm that the facts stated herein are true, correct, and complete in all material fact,
19 not misrepresented and made under the penalties of perjury of the laws of The uNITED STATES
20 and The State of Tennessee.

- 22 1. On November 10, 2015 Clerk of Court, Rutherford County, Tennessee, Melissa
23 Harrell, received a copy of "Affidavit of Commercial Obligation", SEC tracer
24 #2640220.
- 25 2. Dennis Schuelke is a claimant on the referenced "Affidavit of Commercial
26 Obligation". All people are "injured parties".
- 27 3. Spencer Curtis Schuelke is a witness on the referenced "Affidavit of Commercial
28 Obligation, which also serves as as a Writ of injunction/restraint/cease and desist
29 order as follows:

This S.E.C. Tracer Number of #2640220, as related to this Commercial
Obligation Lien, may be used as form of
identification for any & all "Witnesses," "Crime Victims,"

1 and/or "injured parties," when asked for identification by
2 any A.B.A., I.B.A., or D.O.J. contractor, or revenue/tax collector
3 ("Pulbicanus"), (ie; I.R.S. Agent, H.L.S. Agent, F.B.I. Agent, C.I.A. Agent,
4 Sheriff, Sheriff Deputy, Police Officer, etc.).

5 #7.

6 All such "Crown Contractors" are, under the terms & conditions of this
7 International Commercial Obligation Lien/Agricultural Lien/Writ of
8 Injunction & restraint/Cease & Desist Order, prohibited from engaging with,
9 detaining, arresting, incarcerating, harassing, coercing, or intimidating, any
10 "Witness," "Crime Victim," a.k.a. "

11 any Living Being," or citing same under any revenue-bearing statute, code,
12 rule, ordinance, or any other "color of law" infraction, providing the Living
13 Being has

14 NOT harmed or injured another Living Being. [Corporations CANNOT be
15 injured! Only Living Beings
16 can be injured!] Without an "injury," there can be NO
17 crime, and NOWHERE can these revenue-bearing statutes adhere, and no
18 "false presumptions of a crime" shall be made, authorized, or enforced!

19 #8.

20 Any encroachments, or violations, upon the terms & conditions stated above
21 by any "Crown Officer," "Crown Agent," or "Crown Contractor," will result
22 in additional 15 USC penalties being levied upon the corporate, personal, and
23 private properties & assets of these individual "Officers," "Agents," or
24 "Contractors," while operating privately, or in their "corporate capacities."

25 #9.

26 This S.E.C. Tracer Number of #2640220, however, and wherever, presented,
27 will serve as the People's Rescission of Consent, and as fair, proper, and
28 lawful notice to CEASE & DESIST with any& all criminal aggressions,
29 trespasses, and transgressions, while operating on the Land, and/or under the
30 'presumed & alleged' jurisdiction, power, or authority of the
Military/Admiralty Flag of the Crown Templar.

4. Previously notified individuals who are listed as debtors on the referenced lien,
VIOLATED the terms of the international cease and desist order on December 10,
2015, in Rutherford County, Tennessee, in a secret grand jury hearing, with
Royce Taylor presiding.
5. Previously notified individuals who are listed as debtors on the referenced lien,
AGAIN VIOLATED the terms of an international cease and desist order on
Friday, December 11, 2015, Barry Ross Tidwell presiding, in a proceeding at the

1 Rutherford County General Sessions Court, demanding an additional extortion of
2 \$150.

25 Desist order", and subject to additional penalties, are as follows:




